

CCPA/CPRA Notice to California Residents

Pursuant to the California Consumer Privacy Act ("CCPA"), California Privacy Rights Act ("CPRA" and together with the CCPA, "CCPA/CPRA") and other California privacy laws, we are providing the following information to visitors, users, and others who reside in the State of California ("consumers" or "you"). Any capitalized terms used but not defined in this Privacy Notice shall have the meanings ascribed to them by the CCPA/CPRA.

References in this Privacy Notice to "we", "us" or "our" are to the Wealth Management business division of Deutsche Bank, which business division conducts business through the following legal entities: Deutsche Bank AG New York Branch; Deutsche Bank AG Cayman Islands Branch; Deutsche Bank Trust Company Americas; Deutsche Bank National Trust Company; Deutsche Bank Trust Company, N.A.; Deutsche Bank Securities Inc.; Deutsche Bank Trust Company Delaware; DB Private Wealth Mortgage Ltd. and DB Private Clients Corp., depending on which entity maintains your account and/or provides you with products or services.

Information we collect

We collect information that identifies, relates to, describes, references, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or device ("personal information"). In particular, we do collect, and we have collected during your relationship with us, including the last twelve (12) months, if applicable, the following categories of personal information from consumers:

Aggregate information:

To the extent permitted by applicable law, we may use, process, transfer, and store consumer and user data in an anonymous (or pseudonymous) and aggregated manner. We may combine such data with other information collected, including information from third party sources. By using this website (https://deutschewealth.com), you understand that we may collect, use, share and store anonymized (or pseudonymized) aggregated data collected through the products and services we provide to you for benchmarking, analytics, metrics, research, reporting, machine learning, and other legitimate business purposes.

How we use cookies and other technologies

We use certain automatic data collection technologies such as cookies, web beacons, pixel tags and other technologies to collect data, including your personal data, when users or consumers visit the websites or portals, or interact with us, and may share this data with our third-party marketing vendors (including for example, advertising networks and providers of external services like web traffic analysis services and analytics tools). We explain these technologies below.

Cookies. Cookies are small text files placed on a computer by a web server when browsing online and are used to store user preference data so that a web server doesn't have to repeatedly request this information. A user may block cookies by activating the settings on the browser that blocks all or some cookies. However, if a user blocks all cookies (including strictly necessary cookies), a user may not be able to access all or parts of our websites or portals. We use the following cookies:

- Strictly Necessary Cookies. These cookies are required for the operation of our websites and portals. They include, for example, cookies that enable a consumer to log-in to secure areas of our websites and portals.
- Analytical and Performance Cookies. These cookies allow us to recognize and count the number of
 users visiting our websites and portals and see how those users navigate our websites or portals.
 This helps us to improve our websites and portals.
- Functionality Cookies. These cookies recognize a user that returns to our websites or portals. This enables us to personalize our content, greet the user by name and remember preferences, for example, choice of language or region.
- Targeting Cookies. These cookies record visits to our websites or portals and the links followed.
 We use this information to improve our websites or portals and ensure the advertising displayed is relevant to users.

Web Beacons. A web beacon is a small pixel incorporated into a web page or email to keep track of activity on the page or email. A web beacon helps us better manage the content of our websites by informing us of what content is effective.

We obtain the categories of personal information listed above from the following categories of sources:

- Directly from our clients or their agents. For example, from documents that our clients provide to us related to the services for which they engage us.
- Indirectly from our clients or their agents. For example, through information we collect from our clients while providing services to them.
- Directly and indirectly from activity on our website (https://deutschewealth.com/). For example, from submissions through our website portal or website usage details collected automatically.
- Directly from third parties that interact with us in connection with the services we perform.

Our cookies are limited to our websites only and are not designed to follow you when you surf the Internet after leaving our websites. Any marketing cookies that a third-party places on your device may track your browsing history, but we do not have access to any of that information.

If you would prefer not to have the benefits of cookies, your Internet browser can be adjusted to treat cookies in different ways. Depending upon the type of browser you are using, you may be able to configure your browser so that: (i) you are prompted to accept or reject cookies on an individual basis or (ii) you may be able to prevent your browser from accepting any cookies at all. You should refer to the "privacy options" section of your web browser for specific details about cookie security. However, you should also understand that rejecting cookies might affect your ability to perform certain transactions on our websites and our ability to recognize you from one visit to the next.

You can also adjust your cookie preferences directly on our website using the banner at the bottom of the page.

Use of personal information

We may use or disclose the personal information we collect for one or more of the following business purposes:

- To fulfill or meet the reason for which the information is provided.
- To address regulatory and legal requirements.
- To provide you with information regarding our products or services.
- To investigate a potential product or service
- To facilitate an assignment of any loan or piece of a loan
- To provide you with email alerts, event registrations and other notices concerning our products or services, or events or news, that may be of interest to you.
- To carry out our obligations and enforce our rights arising from any contracts entered between you and us, including for billing and collections.
- To improve our website and present its contents to you.
- For testing, research, analysis, and product development.
- As necessary or appropriate to protect the rights, property or safety of us, our clients, or others.
- To respond to law enforcement requests and as required by applicable law, court order, or governmental regulations.
- As described to you when collecting your personal information or as otherwise set forth in the CCPA/CPRA.
- To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by us is among the assets transferred.

Personal information does not include:

- Publicly available information obtainable from government records or from public sources, including any information voluntarily published on the internet.
- De-identified or aggregated consumer information.
- Information excluded from the CCPA's/CPRA's scope, such as:
 - Health or medical information covered by the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and the California Confidentiality of Medical Information Act (CMIA) or clinical trial data.
 - Personal information covered by certain sector-specific privacy laws, including the Fair Credit Reporting Act, the Gramm-Leach-Bliley Act, the California Financial Information Privacy Act, and the Driver's Privacy Protection Act of 1994.

Sharing personal information with service providers

We may disclose your personal information to third-party service providers to the extent necessary or appropriate in connection with our providing services to you. The third-party service providers that receive your personal information from us must agree to keep it confidential and to implement appropriate safeguards to protect your personal information.

During your relationship with us, including the last 12 months, if applicable, we have disclosed the following categories of personal information to third party service providers in connection with our provision of services to our clients (see table above for examples of data for each category):

- Category A: Identifiers
- Category B: Personal information categories listed in the California Customer Records statute
- Category C: Protected classification characteristics under California or federal law
- Category D: Commercial information
- Category F: Internet or other similar network activity
- Category G: Geolocation data (physical location for debit card transactions or mobile applications only)
- Category I: Professional or employment-related information (Current or past job history)
- Category J: Non-public education information (Educational background, student financial information)
- Category K: Inferences drawn from other personal information

We disclose your personal information for a business purpose to the following categories of third parties:

- Service providers
- Third parties to whom you or your agents authorize us to disclose your personal information in connection with products or services we provide to you
- Third-party investors that are performing due diligence on a transaction to purchase all or part of a loan that you invested in

During your relationship with us, including the last 12 months, if applicable, we have not disclosed the following categories of personal information for any purpose:

- Category E: Biometric information
- Category H: Sensory data

Your rights and choices

The CCPA/CPRA provides consumers (California residents) with specific rights regarding their personal information. If you are a California resident, this section describes your CCPA/CPRA rights and explains how to exercise those rights.

Because we do not sell or share your information with third-parties (other than those necessary to provide the product or service you requested), the Right to Limit selling or sharing your personal information and the Right to Limit the disclosure of sensitive personal information do not apply. Also, we do not sell or share your personal information for targeted behavioral advertising.

Access to personal information

You have the right to request that we disclose certain information to you about our collection and use of your personal information during your relationship with us, including the last 12 months, if applicable. Once we receive and confirm your verifiable consumer request, in accordance with the regulation, we will disclose to you:

- The categories of personal information we collected about you.
- The categories of sources for the personal information we collected about you.
- Our business or commercial purpose for collecting that personal information.
- The categories of third parties with whom we share that personal information.
- The specific pieces of personal information we collected about you (also called a data portability request).
- If we disclosed your personal information for a business purpose, a list identifying the personal information categories that each recipient obtained.

You may submit two access requests in a 12-month period.

Correct inaccurate personal information

During your relationship with us, you have the right to request that we correct inaccurate personal information we might have on you. Once we receive and confirm your verifiable consumer request, our business shall use commercially reasonable efforts to correct the inaccurate personal information as directed by you.

Delete personal information

You have the right to request that we delete any of your personal information that we collected from you and retained, with certain exceptions. Once we receive and confirm your verifiable consumer request, we will delete (and direct our service providers to delete) your personal information from our records, unless an exception applies.

We may deny your deletion request if retaining the information is necessary for us or our service providers to:

- 1. Complete the transaction for which we collected the personal information, provide a good or service that you requested, take actions reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform our contract with you.
- 2. Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for such activities.
- 3. Debug products to identify and repair errors that impair existing intended functionality.
- 4. Exercise free speech, ensure the right of another consumer to exercise their free speech rights, or exercise another right provided for by law.
- 5. Comply with the California Electronic Communications Privacy Act (Cal. Penal Code § 1546 seq.).

- 6. Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when the information's deletion may likely render impossible or seriously impair the research's achievement, if you previously provided informed consent.
- 7. Enable solely internal uses that are reasonably aligned with consumer expectations based on your relationship with us.
- 8. Comply with a legal or regulatory obligation.
- 9. Make other internal and lawful uses of that information that are compatible with the context in which you provided it.

Exercising access to data, data correction, data portability, and data deletion rights

To exercise the access, data correction, data portability, and deletion rights described above, please submit a verifiable consumer request to us by either:

Only you or a person registered with the California Secretary of State that you authorize to act on your behalf, may make a verifiable consumer request related to your personal information. You may also make a verifiable consumer request on behalf of your minor child.

You may only make a verifiable consumer request for access or data portability twice within a 12-month period. The verifiable consumer request must:

- Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative.
- Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to it.

We cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request and confirm the personal information relates to you. Making a verifiable consumer request does not require you to create an account with us. We will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.

Response timing and format

We endeavor to respond to a verifiable consumer request within 45 days of its receipt. If we require more time (up to 90 days), we will inform you of the reason and extension period in writing. We will deliver our written response by mail or electronically, at your option. Any disclosures we provide will only cover the 12-month period preceding the verifiable consumer request's receipt. The response we provide will also explain the reasons we cannot comply with a request, if applicable. For data portability requests, we will select a format to provide your personal information that is readily useable and should allow you to transmit the information from one entity to another entity without hindrance.

We do not charge a fee to process or respond to your verifiable consumer request unless it is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a fee estimate before completing your request.

Non-discrimination

We will not discriminate against you for exercising any of your CCPA/CPRA rights. Unless permitted by the CCPA/CPRA, we will not:

- Deny you goods or services.
- Charge you different prices or rates for goods or services, including through granting discounts or other benefits, or imposing penalties.
- Provide you a different level or quality of goods or services.
- Suggest that you may receive a different price or rate for goods or services or a different level or quality of goods or services.

Employee and Job Candidate Data

Our employees, contingent workers, and prospective employees (job applicants) that live in California have the same rights over their employment and job application data. We do not sell or share any employee or job applicant data with anyone other than third-party service providers necessary to complete requested services (e.g., payroll and benefits management, background check vendor).

Business-to-Business Data

In the course of business with vendors, clients, service providers, and others, we may collect personal data from California-resident individuals solely because they are employees of vendors (potential or actual), clients (potential or actual), and other business partners. These individuals have the same rights over their personal data as other California consumers.

We do not sell or share any personal information, including "business-to-business" data, with anyone other than necessary third parties that are essential to completing the business between us.
